Title IX of the Education Amendments of 1972 (20 U.S.C. 1681) is a federal law that ensures that no person experiences sex discrimination, including sex based harassment or sexual violence, in federally funded education. The federal regulations provide protections from all forms of sex based harassment, including sexual violence and unwelcome sex based conduct that creates a hostile environment by limiting or denying a person's ability to participate in or benefit from a school's education program or activity

- COMPLAINANT: An individual who is alleged to be the victim of sex based harassment.
- RESPONDENT: An individual who is alleged to be the perpetrator of sex based harassment.
- **COMPLAINT:** A document filed by a Complainant (or parent/guardian) and/or signed by the Title IX Coordinator alleging sex based harassment against a Respondent and requesting that the school district investigate the allegation.

Completed forms must be emailed to EEO-TitleIX@fcps.org In your correspondence, please include:

- The complainant's name, address, and telephone number where the complainant should be reached during business hours;
- Information about the person(s) injured by the alleged sex based harassment;
- The name and location of the FCPS school/office where the alleged sex based harassment occurred; and
- A description of the alleged sex based harassment in sufficient detail to enable FCPS to understand what occurred and when the incident happened.
