A. **Overview:** This recommendation is to establish contracts with community based partners to provide summer enrichment activities and services, as well as, site coordination and facilitation at Monocacy Elementary and Monocacy Middle Schools.

3. Other Facts:

- Frederick County Public Schools was awarded a three year grant from the Maryland State Department
 of Education (MSDE) to establish a 21st Century Community Learning Center program at Monocacy
 Elementary and Monocacy Middle Schools.
- The purpose of this program is to create community learning centers that provide students with academic enrichment opportunities, as well as, additional services designated to complement their regular academic program.
- The following enrichment activities will be provided by the community based partners: site supervision and staffing (Boys and Girls Club of Frederick): soccer (Football Club of Frederick); drama (Maryland Ensemble); hands-on science, technology, and engineering (Maryland Science Olympiad); youth development (Teamlink); sport, fitness, dance (YMCA of Frederick County); and art (Young Rembrandts).
- Summer programs will be offered in 2016, 2017 and 2018.
- The contract will be administered by Doreen Bass, Grants Coordinator and Charlene Gomes, Program Administrator for School Administration and Leadership.
- 4. Source of Funding: This grant was approved at the Board of Education meeting on December 16, 2015.
- B. **Recommendation:** Staff recommends that contracts be awarded to Boys and Girls Club of Frederick County, Football Club of Frederick, Maryland Ensemble Theatre, Maryland Science Olympiad, Teamlink, Inc., YMCA of Frederick County and Young Rembrandts in accordance with the attached budget summary.
