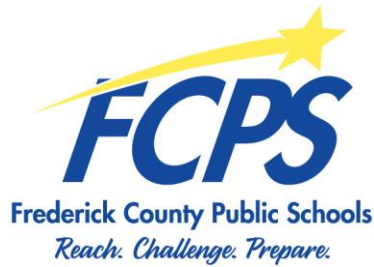

As a result of the pre-proposal meeting held on November 4, 2015, the following revisions, clarifications are comments are provided for your information. No additional questions will be entertained prior to the proposal opening.

1. The pre-proposal meeting was not a site visit, as this is an open requirements request for proposal. Attendance at that meeting was not mandatory.
2. All bidders need to complete the AIA Document, in conjunction with the FCPS Supplemental Questionnaire, as per the instructions on Page 27 of the RFP.
3. Page 28, Minimum Qualifications, #1.f. revise to read:
"Preferred ability to store contents off site while the reconstruction process is under way, if needed, and at a negotiated rate."
4. Page 28, Minimum Qualifications, #3.c. revise to read:
"Must be located so as to be able to respond to emergencies within two hours or less."
5. Page 38, #5.1, revise to read:
"SUBMIT AN AUDITED BALANCE SHEET FOR TAX YEAR 2014 SHOWING ASSETS AND LIABILITIES."
