 - f. Should the awarded vendor, at any time during the life of the contract, sell materials of similar quality to another customer, or advertise special discounts or sales, at a price below those quoted within the contract, the lowest discounted prices shall be offered to FCPS.
- 2. Clarification: Vendors may submit tiered catalog discounts under Form of Proposal 1 Percentage Discount from Catalog Pricing. Please make a note on the Form of Proposal and submit the tiered discounts with your submission. Vendors may submit volume discounted pricing under Revised Form of Proposal 2 Market Basket. Please make note on the Form of Proposal and submit the volume discounted pricing with your submission.
