Please be advised of the following additions, clarifications, and answers to questions that we have received.

- 1. What credit/payment terms are requested?
  - ➤ Net 30.
- 2. Will the tax exemption form be provided prior to service?
  - > Yes
- 3. Does the pricing lock need Board of Education approval before it can be executed?
  - No.
- 4. Clarify the timing of the lock and how long pricing will need to be held.
  - Reference page 20, Section 3, Schedule and Timing.
- 5. Provide the definition of full requirements.
  - This a 100% swing product where the price remains the same for all volumes used.
- 6. Is the parental guarantee a requirement at the time of bid submission or only after award?
  - > Evidence of the Parental Guarantee, if applicable, would be required with the pricing submission.
- 7. Is a completed Certificate of Insurance due at the time of supplier qualification or at the time of award?
  - ➤ Evidence of company's insurability is required as a supporting document with the proposal. A Certificate of Insurance, with FCPS as the certificate holder, is due only from the awarded vendor and is due within ten days of notice of award.
- 8. Will Frederick County Schools be willing to utilize the supplier's contract document?
  - No, we will only use the FCPS contract.
- 9. Would the FCPS be interested in other product offerings outside of the Fixed Price product?
  - No.
- 10. Should the two accounts with BGE and UGI be included in the pricing?
  - ➤ It is not mandatory that these two accounts be included.
- 11. Should the inactive accounts be included in the pricing?
  - No.



- 12. Would you be able to provide the complete account list in Excel with the correlated addresses?
  - > Attached.
- 13. How often have you added/deleted accounts over the last 5 years?
  - Accounts are usually added only when new schools are built. Deletions usually only occur if a school is demolished and rebuilt in a new location.
- 14. Does the FCPS have any scheduled building projects or closures scheduled in the next 3 years?
  - > Two new elementary schools will open in August 2018.
- 15. Would the FCPS accept billing in Dekatherms?
  - No.
- 16. Would the FCPS accept billing the gas deliveries to the city gate?
  - No.
- 17. As the supplier is delivering a commodity to the city-gate and the utility is transporting it across their system, what are the expectations for the supplier to warranty the delivery of a product that is on another's distribution system?
  - > FCPS will pay the balancing fees. Lost and unaccounted for product is the responsibility of the supplier.
- 18. Are Performance and Payment Bonds required?
  - ➤ Performance bonds are not currently required. If they are, FCPS will negotiate payment of the cost of the bonds with the awarded vendor.
- 19. Regarding Page 15, Section 21, can you please confirm that the right to extend the terms and conditions to other agencies does not include price?
  - Confirmed.
- 20. If a suppler does not offer payment via credit card as a payment method, is FCPS interested in other types of payment methods including ACH direct payments, EFT direct debit, and online payment of invoices though a customer portal?
  - ➤ Possibly. FCPS currently pays gas invoices via check.
- 21. Regarding the balancing fees, would FCPS consider waiving the requirement to bill these as a separate line item?
  - No, because they change during the year.
- 22. On page 16 under Section 22 a., Billing and Payment, it says invoices shall be submitted to accounts.payable@fcps.org, etc. Is this applicable to this bid?
  - ➤ No. Reference page 22, # 9. Billing for the correct information. In the event of conflicting terms, Specific Terms and Conditions—Section II takes precedence over General Terms and Conditions—Section I.
- 23. Would it be possible to bill separately by account and follow-up with a monthly spreadsheet itemizing the billing information as described in this section?
  - No.



- 24. Does Frederick County Public Schools participate in the SBR (Small Business Reserve) program? Would our status as a MD SBE be taken into consideration during the bid evaluation?
  - > FCPS does not have set asides or preference laws of any kind.
