- Approximately \$598,414 has been expended to date in FY18.
- Selection is based on the total score of each bidder's technical and cost proposals.
- Three agencies received a score of zero, as indicated on the scoring summary, because their proposals were not submitted in accordance with specifications.
- The average service hour rate for LPN's is 6.5% higher than the last contract, and the RN hourly rate is 8.6%
- This contract will be administered by Jenifer Waters, Health Service Specialist.
