A. **Overview:** This recommendation is to establish contracts with community-based partners to provide summer enrichment activities and services, as well as, site coordination and facilitation.

3. **Other Facts:**

- Frederick County Public Schools was awarded a three-year grant from the Maryland State Department of Education (MSDE) to operate a 21st Century Community Learning Center program at Hillcrest Elementary, Waverley Elementary, Lincoln Elementary, North Frederick Elementary, Monocacy Elementary and Monocacy Middle Schools.
- The purpose of this program is to create community learning centers that provide students with academic enrichment opportunities, as well as, additional services designated to complement their regular academic program.
- The following enrichment activities will be provided by the community-based partners: site supervision, sports, fitness, dance, cooking and drama (YMCA of Frederick County); and youth development (TeamLink).
- Summer programs will be offered in 2019, 2020, and 2021.
- The contract will be administered by Doreen Bass, Grants Coordinator, School Administration and Leadership.

4. **Source of Funding:** This grant was approved at the Board of Education meeting on November 14, 2018.

B. **Recommendation:** Staff recommends that contracts be awarded to TeamLink, Inc. (Frederick, MD) and YMCA of Frederick County (Frederick, MD), in accordance with the attached summary.
