BID 19M2 HEATING OIL

FACT SHEET

A. **Overview:** This recommendation is to establish a contract for the supply and delivery of heating oil to Frederick County Public Schools. Sealed proposals were opened on May 28, 2019.

1. Bid participation:

18 bids downloaded 5 companies submitted bids

2. Bids were received from:

James River Solutions dba: JRS (Ashland, VA) Mansfield Oil Company of Gainesville, Inc. (Gainesville, GA) Petroleum Traders Corporation (Fort Wayne, IN) Shipley Fuels Marketing, LLC dba: Shipley Energy (York, PA) Southern States Cooperative, Inc. dba: Frederick Petroleum Service (Frederick MD)

3. Other facts:

- This contract shall be effective from July 1, 2019 through May 30, 2023, with one two-year renewal option available.
- Prices were requested for a fixed differential cost (comprising the freight, profit and overhead) plus applicable taxes, and based on tank wagon or transport delivery of heating oil to various sites.
- Mansfield Oil Company duplicated their per gallon mark-up in the total cost section of the form of proposal. They did not include the cost per gallon in the total cost, resulting in an non-responsive bid submission.
- Deliveries are priced by tank wagon for loads of 150 gallons to 5000 gallons, and by transport for loads of 5001 to 7500+ gallons.
- All prices (mark-up) shall remain firm through the initial and renewal contract terms.
- Prices are based on a fluctuating cost of oil, plus a fixed differential cost comprising freight, profit and overhead, plus applicable taxes.
- Approximately \$600,000 was expended in FY19.
- The contract will be administered by Charles Dalphon, Energy and Utility Coordinator.
- 4. **Source of funding:** FY20 Approved Operating Budget and contingent upon Board approval of FY21, FY22, and FY23 Operating Budgets.
- B. **Recommendation:** Staff recommends the contract for Bid 19M2, Heating Oil, be awarded to James River Solutions dba: JRS (Ashland, VA), per the attached bid tabulation.
