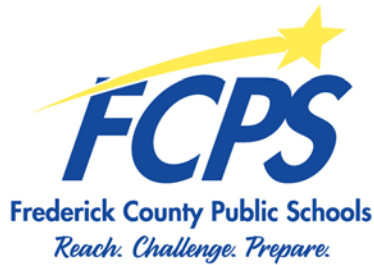

3. On page 43, 1.19, vendors are asked to provide an organizational chart. FCPS would like to see the organizational chart for the business office that is submitting the proposal, as well as a chart for where the business office fits into the larger organization, should that be true for your company.
