A.	Overview: This recommendation is to establish a contract to qualify a minimum of two licensed, commercial
	contractors to perform emergency remediation and restoration services for water, mold, fire, and disaster
	damage. Bids were opened on November 14, 2019.

#### 3. Other Facts:

- The initial contract term shall be effective from the date of award through December 31, 2021, with one two-year renewal option available.
- Work will be performed on an "indefinite quantity" basis due to the uncertainty of actual requirements.
   The amount of business granted to each firm will be determined based on a firm's expertise and current work load, or on a rotating basis, as determined by staff.
- Payment for services will be coordinated between Frederick County Public Schools (FCPS), the
  insurance carrier, and the contractor. Any amount that is not covered by insurance will be paid to the
  contractor from FCPS operating funds.
- Approximately \$308,000 was expended in FY19.
- The contract will be administered by Laura Olsen, Environmental Compliance and Occupational Safety Manager.
- 4. **Source of Funding:** FY20 Approved Operating Budget and contingent upon Board approval of FY21 and FY22 Operating Budgets.
- B. **Recommendation**: Staff recommends that RFP 20MISC3, Qualification of Emergency Remediation and Restoration Contractors, be awarded to Barkay, Inc. dba: Paul Davis Restoration (Frederick, MD) and Vintage Cleaning Corporation, Inc. dba: ServiceMaster Restoration of Frederick, Montgomery, Howard, Prince George's and Washington Counties (Frederick, MD).
