Failure to include this information at the time of the bid opening will be grounds for rejection of the bid. This data may be submitted electronically on a USB Flash Drive or CD. Materials Safety Data Sheets are required with every paint shipment.
- 6. Please note the Form of Proposals are posted online, in electronic format for your convenience. An original "hard" copy along with the electronic copy in <u>excel format</u> (on CD or USB Flash Drive) is required.
