A.	Overview:	This recommendation	is to renew t	ne contract	for professional	auditing se	rvices for	Frederick
County Public Schools.								

1. Other facts:

- Frederick County Government (FCG), Frederick County Public Schools (FCPS) and Frederick Community College (FCC) jointly requested proposals from qualified firms of certified public accountants to audit their financial statements for the fiscal years ending June 30, 2015 and June 30, 2016, with the option of auditing their financial statements for each of the four subsequent years.
- If approved, this final renewal term will be effective from July 1, 2020 through June 30, 2021.
- FCG approved contract renewal on February 4, 2020.
- FCPS spent \$58,000 for auditing FY19 financial statements.
- The contract will be administered by Melissa Rollison, Financial Reporting Manager.
- 2. Source of Funding: Contingent upon Board approval of FY21 Operating Budget.
- B. Recommendation: Staff recommends renewal of the contract for RFP 15MISC5, Professional Auditing Services for Frederick County Public Schools to SB & Company of Hunt Valley, Maryland, at a cost of \$60,000 for auditing FY20 financial statements.
