RFP #21A2 Request for Letter of Interest Design Build Services for Limited Renovation of Thurmont Elementary School

Frederick County Public Schools is soliciting Design-Build services for a limited renovation of Thurmont Elementary School (TES), located at 805 East Main Street, Thurmont, MD 21788. The single-story building was originally constructed in 1955. Additions to the school were made in 1959 and 1976, resulting in a facility of 60,331 gross square feet. The academic wings largely consist of open classrooms with demountable partitions.

A facility and program assessment was completed in September 2020 to determine opportunities for a limited renovation at Thurmont ES. The study analyzed the condition of all building systems to recommend projects that would extend the life of the building for 20 to 30 years. The current space usage was also compared to the current Board of Education (BOE) approved elementary educational specifications as scaled for the current state rated capacity (SRC) of TES of 368 students, which led to the development of a test-fit option. At the conclusion of the study, staff recommended and the BOE approved the scope of the limited renovation project for TES along with development of a full educational specification document. A copy of the facility and program assessment study is available upon request by sending an email request to Kim Miskell at kim.miskell@fcps.org. The educational specifications will be provided to firms invited to submit a full technical and fee proposal.

The school serves students in 3rd through 5th grades and has an existing SRC of 368 students. The September 2019 equated enrollment was 312 students. The school is operating at 85% of capacity. After enclosing the open space classrooms and adding spaces to meet the current educational program, FCPS anticipates that the SRC will be 483 at the completion of the project.

The limited renovation will be focused in the academic wings, totaling approximately 24,000 sf although some work will be done throughout the building where noted. The following systems will be addressed:

- Architectural
- Structural
- Mechanical
- Lighting
- Electrical
- Plumbing
- Fire Safety
- Communication

In addition to addressing systemic issues, the limited renovation will also address spatial and program issues primarily in the academic wing. Anticipated work within the academic wing includes, but is not limited to, construction of fixed walls to replace the demountable partitions; reconfiguration of HVAC ductwork, lighting and electric wiring and controls, security and internet communication devices, fire/smoke detection and alarms, and reconfiguration and construction of bathroom facilities to meet ADA and code requirements. Also, replacement of HVAC controls, all room heating units, casework, drinking fountains, ceiling grid and tile, all interior and exterior doors and windows, entire roof, flooring (with the exception of the art room and the terrazzo flooring) and main electrical panel, renewal of wall finishes, upgrade of chalkboards to whiteboards, selective repointing of exterior (five percent of the area assumed), addition of lockers, installation of a wet-pipe sprinkler system, new security vestibule, air-conditioning in

gymnasium and new public address system. Limited site work will also be included to improve the main entrance. The Design Builder will be responsible for verifying the scope of work.

The limited renovation project is expected to take place over two summer breaks with the school remaining occupied by students, faculty and administration during the school years with limited disruption due to the project. FCPS will consider opportunities to conduct limited work during other school breaks or in areas of the building that can be isolated during the school year. Design and permitting of the project is expected to begin in June 2021 upon award of the Design-Build contract and continue through May 2022. The majority of the Phase 1 construction work will occur over the 8-week summer break between June and August 2022 but may also occur during student breaks and when the work will not disrupt the students' education. Similarly, the second phase of construction would occur over the 8-week summer break between June and August 2023 or during student breaks. The anticipated construction budget for this project is \$8.3 Million (including construction, site, design, and Design Builder Fees as well as permit fees).

Only letters of interest from Design-Build teams will be considered. The Design-Build team will be led by the design builder and include such professionals as architect, civil, mechanical, electrical and structural engineers, communication/data network consultants, food service consultants, etc. All members of the Design-Build team shall be included in the response to this solicitation.

Interested Design-Builders shall submit an electronic cover letter indicating their interest in this project and listing any relevant experience that qualifies the team for this project. You must also identify the Design Builder project manager, and the design team project manager, and names of all members of your design team including sub-consultants. In addition to individual names of sub-consultants, include company names, addresses, phone numbers and emails. Please utilize SF330 forms parts I and II.

CERTIFICATION OF COMPLIANCE

- 1. All Contractors, subcontractors or vendors must abide by FCPS Board policies and regulations while working on FCPS property.
- 2. Maryland Law requires that any person who enters into a contract with a county board of education may not knowingly employ an individual to work at a school (or FCPS facility) if the individual is a registered sex offender. Please reference §11-113 of the Criminal Procedure Article of Maryland Code for penalty.
- 3. Be advised that individuals who are registered sex offenders are not eligible to work on any FCPS project. The Contractor must initially check the Maryland Department of Public Safety & Correctional Services' MARYLAND SEX OFFENDER REGISTRY and search for the name of any employee to be assigned to work on this project. This applies to subcontractors and material/equipment suppliers as well.
- 4. In the event that a registered sex offender is discovered to be working on a FCPS project, whether through employment by the prime Contractor, subcontractor or vendor, the site superintendent will immediately remove the individual from the premises and permanently terminate his work assignment. FCPS may terminate this contract as a result if the Contractor is unable to demonstrate he has exercised care and diligence in the past in checking the Maryland registry.
- 5. Effective July 1, 2015, amendments to §6-113 of the Education Article of the Maryland Code further require that a contractor or subcontractor or vendor for a local school system may not knowingly assign an employee to work on school premises with direct, unsupervised, and uncontrolled access to children, if the employee has been convicted of, or pled guilty or nolo contendere to, a crime involving:
 - a. A sexual offense in the third or fourth degree under §3-307 or §3-308 of the Criminal Law Article of the Maryland Code.
 - b. Child sexual abuse under §3-602 of the Criminal Law Article of the Maryland Code or any other State; or
 - c. A crime of violence as defined in §14-101 of the Criminal Law Article of the Maryland Code or any other State
- 6. With the passing of Maryland Law MD. Code, Educ. 6-113.2, employers of all contracted staff must obtain background information relating to child sexual abuse or sexual misconduct. This means that all contracted staff having direct contact with students must meet all of the FCPS and Maryland State Department of Education (MSDE) requirements before doing business with FCPS. See: Maryland State Department of Education Website; House Bill 486 Child Sexual Abuse and Sexual Misconduct Prevention; MSDE Guidelines For MD. Code, Educ. 6113.2; and Employment History Review Form for Child Abuse and Sexual Misconduct for additional information.

In addition, there has been no change to the current FCPS requirement, that all contracted staff who have contact with students are required to be fingerprinted in order to obtain a criminal background check. Fingerprints and background check are still an enforced FCPS requirement.

Under recent amendments to §5-561 of the Family Law Article of the Maryland Code, each contractor, subcontractor, or vendor shall certify by signing this affidavit that any individuals in its work-force including sub-contractors, have undergone a criminal background check, including fingerprinting, if the individuals will work in a FCPS school facility in circumstances where they have direct, unsupervised, and uncontrolled access to children.
