- This contract will be effective from the date of award through August 31, 2022. The contract may be
  renewed for two additional one-year renewal terms at the discretion of the Board of Education with all terms
  and conditions of the original contract unchanged.
- A committee of FCPS staff independently reviewed and evaluated each proposal. Selection was based on the total score of each vendor's technical and cost proposal.
- Cost Proposals were scored from the top four highest technical score recipients.
- The contract will be administered by Tom Saunders, Instructional Director, Middle Schools, School Accountability and School Administration Department.
- 4. **Source of funding:** FY 22 Supplemental Instruction and Tutoring Grant, with the first renewal able to be covered under FY23 Supplemental Instruction and Tutoring Grant, and contingent upon FY24 Operating Budgets, should the services continue upon grant expiration, the services are identified as still required, and no new grant has been received.
