This addendum is being issued to provide additions, corrections, clarifications and answers to certain questions raised referencing the original proposal package and any resultant contract for the above proposal.

#### **Clarifications:**

- 1. The intent under the Scope of Work (SOW) is that the entire service be manned, with no remote service. If a vendor has an alternate plan to complete the SOW that incorporates remote services, they may include pricing for that service as an alternate, along with an explanation as to how that would go.
- 2. For closed captioning, FCPS has tested what is available from YouTube and decided that a separate closed-captioning service be provided. FCPS does <u>not</u> want to utilize the captioning from YouTube.

The following is a list of questions received with responses.

1. Will MSM support be there for Audio Feed?

There will be a tech person on site from MSM

2. Will there be a tech person on the site from MSM for lighting?

MSM does not provide stage lights, no additional lighting is needed.

3. What is the Platform streaming to?

FCPS MD YouTube Channel

4. Can multiple pricing options be submitted?

Multiple pricing options may be submitted.

5. In regards to cameras, row distance to the podium/stage?

Length of a basketball court, plus 10' or so. There is a balcony for a raised shot.

6. Are robotic cameras allowed? Will there be a need for tight shots?

The vendor may use robotic cameras as part of their submission, if they deem it applicable for the scope of work. There will be the need for tight shots. The vendor will need to plan accordingly.

7. Audio Feed (separate channels)?

MSM will provide one main out channel.

8. What will be the audience size?

Depends on the school and number of tickets plus students. 3K live people on site is the estimate.


