RFP 22A2 MONOCACY ELEMENTARY SCHOOL LIMITED RENOVATION PROGRAM DESIGN BUILD

FACT SHEET

A. **Overview**: The recommendation is to establish a contract with a design-build team for the limited renovation at Monocacy Elementary School.

1. RFP Participation:

119 proposals downloaded 12 companies submitted a proposal

2. Proposals were received from:

3. Other facts:

- Monocacy Elementary School was originally constructed in 1989 and has had no renovations or additions. The school currently serves students in grades Pre-K through 5 and has a state rated capacity of 574 students.
- A facility and program assessment were completed in September 2021 to analyze the condition of all building systems to recommend projects that would extend the life of the building for 20-30 years. The current space usages were also compared to the current educational specifications.
- The limited renovation will be focused in the academic wings to address spatial and program issues, as well as, the following systems: building envelope, mechanical, lighting, electrical, plumbing, fire safety and communication.
- The project is scheduled to be completed over two summer breaks, June to August, 2023 and 2024.
- Staff members from different departments reviewed and scored the letters of interest. Firms scoring a total of 90 points or higher were invited to submit full technical and fee proposals. A team of five staff members reviewed the technical proposals and interviewed each of the candidate firms. Fee proposals were opened for firms scoring a total of 75 point or higher. Selection is based on the total score of each vendor's technical and cost proposal.
- The contract will be administered by Adnan Mamoon, Director of Capital Programs, Capital Programs Department.
- 4. Source of Funding: Contingent upon FY23 and FY23 Capital Improvement Projects Budget and IAC approval.
- B. **Recommendation**: Staff recommends award of the contract for RFP 22A2, Monocacy Elementary School Limited Renovation Program Design Build to Oak Contracting, LLC (Towson, MD), at a cost not to exceed \$1,464,578.
