Questions Received with Responses

- 1. Will the district accept proposals from companies that ONLY provide teletherapy in regards to these services? Under this proposal, services need to be SAME location.
- 2. Will the district accept services delivered via teletherapy? Under this proposal, services need to be SAME location
- 3. Can we provide school psychologists to deliver the services rather than counselors? No
- 4. Are electronic signatures, such as DocuSign, acceptable? Yes
- 5. There are not a lot of specifics in this procurement request. Do you have any further requirements for what information you want in the written proposal?
 Please provide sufficient information in the written proposal that details your company's overall qualifications, experience and capacity to provide the services requested in this solicitation.
