This addendum is being issued to provide additions, corrections, clarifications and answers to certain questions raised referencing the original proposal package and any resultant contract for the above bid.

Question Received with Response

1. In line A-2 it is asking for SQ YD which, I'm assuming is meant to be cubic yard. It is asking for the blown in price. Normally we have a set price for blown in Woodcarpet that includes all items, travel time, labor, equipment, and Material. So, I am not sure how to set a labor rate for the B line items, because we don't really charge a customer for labor by the hour. So, my question is can I just give a per cubic yard price for blown in installed mulch that includes everything or do I need to separate the price of mulch and the price of labor for installation.

You are correct it should be cubic yard instead of square yard. Also, where it is listed as "blown in place" or "placed" it means all-inclusive of material, labor and equipment necessary to put in place a cubic yard of material. The "B" section for labor charges is for when the other groups in the system may need to hire outside help to support basic landscaping services such, weeding and landscape mulch for around trees and gardens. It can also be used even with the wood carpet portion for when there may be needs for things out of the normal "blown in place" crew so that you have a contract means to cover additional people if necessary.
