23MISC12 Revised Scope of Work

The FCPS Board and Broadcast Control Room Replacement Project will provide staff and the community a modernized engagement experience for, but not limited to, Board of Education meetings, professional development classes, and hybrid (virtual/in-person) meetings. Below is an overview of each room.

Control Room

- Decommission old equipment, reduce server racks
- The following equipment will be relocated prior to decommissioning to keep FCPS TV up and running during the project, then integrated into the new setup. This will be a coordinated effort between Public Affairs, Department of Technology Infrastructure, Comcast, and the selected vendor.
 - Tightrope Cablecast VIO 3U
 - o ENCO 2U
 - o Swagit 1U
 - o Comcast Fiber 1U
 - O Comcast Encoder 1U
- Design and Reposition work area (switcher, camera control, audio board, pc, etc.) for live meetings to reduce overall footprint of the broadcast control room.
- Quiet server racks to minimize machine noise
- Replace HD router
- Necessary broadcast equipment for High-Definition (video router, converters, etc.)
- Provide HD-SDI signal with embedded audio and closed captions to Comcast
- Provide HD-SDI signal with embedded audio and closed captions to Swagit for archiving of BOE meetings
- Replace existing NewTek Tricaster and controller with newer model
 - Playback audio/video from DDR to board room
 - Ability to have virtual meetings as input on switcher to broadcast. The supported platform for video conferencing is Google Meet. As more information is provided by the Department of Technology Infrastructure (DTI) we will update what platforms are supported by FCPS.
- Integrate or replace existing Panasonic camera controller to control new cameras in board room
- Replace Cablecast hardware and software to control FCPS TV programming and bulletin board.1) The current Tightrope Cablecast VIO 2 Version 7.2.6 machine was purchased in late 2020. There is currently nothing this machine can't do that we'd like to have. However, we'd like the vendor to confirm the current machine is compatible with the upgrade to the infrastructure. If not, what Tightrope Cablecast machine would be recommended? Can Cablecast Closed Captioning be added to this device and possibly replace the ENCO EnCaption machine?
- Replace existing Yamaha audio board
 - VOG mic to communicate with board room
 - Control room audio monitoring
- Capability to record minimum 2 back-up digital files of live events in addition to recording on device used for channel programming

- TV for live feed from Comcast
- Provide room wiring diagram

Board Room

- Install new audio system and rack in closet
 - o 10 dais microphones are to be wired
 - o 30 wireless microphones (26 conference/goosenecks, 2 hand held, 2 lapel) will be used in multiple setups.
 - o Two systems utilizing same microphones; house audio and broadcast audio
 - Setups include but are not limited to; broadcasting live BOE meetings, recording in-person/hybrid staff and/or committee meetings, and recording/conducting professional developments.
 - o 2 locations (dais and round table/U-shaped) needed for board meetings
 - Room needs to have auto-mode when not broadcasting for presenters (pc audio, wireless mics, lavalier)
- Replace and reposition PTZ cameras to rear of room
- Replace projectors and reposition if needed
 - The middle projector and motorized screen can be replaced with a large (97" minimum) display. The display, just like the projectors, will be need the capability to show; presentation materials from the board room computer, video playback Tricastor DDR, virtual participants in hybrid meetings, etc. Provide a cost breakout for both replacing the current projector with a new projector and the display option.
- Touchpad controller for projectors, motorized screens, and audio setups
 - \circ Total of 3 control room and board room (2)
- Replace/reposition presentation table
 - Computer needs connection to projectors and house audio
- Provide an option to replace the dais that will reduce clutter, enhance appearance and functionality
- Replace current setup for confidence monitors on dais with larger monitor in rear of room
- Dais wire clean up and declutter
- On-air light to indicate control is ready to go live
- Dedicated auto-mated camera(s) and system for recording and sharing meetings and/or professional developments
- Dedicated camera and system for conducting hybrid meetings
 - Room audio and camera feed to virtual participants
 - Virtual participants audio and video feed to room
- Lighting
 - O Dais front, seats, and rear wall
 - Presentation table
 - Area for photography awards, recognitions, etc.
 - Flash system for photography
- Provide room wiring diagram




