A. **Overview:** This recommendation is to establish a contract for Construction Management at Risk Services for the replacement of Green Valley Elementary and Valley Elementary Schools. Proposals were opened on June 2, 2022.

1. **RFP participation:**

- 10 proposals downloaded
- 7 companies submitted proposals

2. Proposals were received from:

Dustin Construction, Inc. (Ijamsville, MD) Gilbane Building Company (Baltimore, MD) Keller Construction Management, a Division of Keller Brothers Inc. (Mt. Airy, MD) MCN Build, Inc. (Baltimore, MD) Oak Contracting, LLC (Towson, MD) Turner Construction Company (Baltimore, MD) Whiting-Turner Contracting Company (Towson, MD)

3. Other Facts:

- Technical proposals were solicited from the ten pre-qualified construction management at risk firms under RFQ 20MISC11, Construction Management Services.
- Scope of work includes services associated with the planning, design, cost estimating, bidding, construction, close-out and warranty period.
- Staff members from different departments reviewed and scored the technical proposals. All firms that submitted a technical proposal were interviewed. The cost proposals were opened for firms scoring a total of 70 points or higher. Selection is based on the total score of each vendor's technical and cost proposal.
- The contract will be administered by Brad Ahalt, Senior Project Manager, Capital Program Department
- 4. **Source of Funding:** FY23 Approved Capital Improvement Projects Budget and contingent upon subsequent years' budget allocations.
- B. **Recommendation:** Staff recommends that RFP 22C3, Construction Management at Risk Services for Green Valley and Valley Elementary School Replacement Projects, be awarded to Dustin Construction, Inc. at a cost not to exceed \$5,524,150 (Green Valley Elementary = \$2,725,365; Valley Elementary = \$2,798,785).
