- The contract shall be effective from date of award through May 31, 2026, with three two-year renewal
 options available.
- A committee of Frederick County Public Schools staff independently reviewed and evaluated each
 proposal. Purchasing opened the cost proposals, but did not share the results with the evaluation
 committee, until technical proposals were scored and meeting with evaluation committee was
 conducted to make recommendation to the Board.
- Approximately \$87,477 was spent in FY22 and \$131,051 has been spent to date in FY23.
- The contract will be administered by Tim Thornburg, Senior Manager, Employee Relations/Contract Management, Human Resources Department.
- 4. **Source of funding:** FY23 Approved Operating Budget and contingent upon Board approval of FY24, FY25, and FY26 Operating Budgets.
