## FACT SHEET

A. Overview: This recommendation is to establish contracts with qualified firms for providing an institutionally based investment platform, record keeping, administration and communication services associated with providing and maintaining 403(b) and 457(b) plans. Proposals were opened on March 27, 2023.

### 3. Other Facts:

- The initial term of the contract will be effective from date of award through June 30, 2026, with two additional two-year renewal options available, at the discretion of the Board of Education.
- Frederick County Public Schools (FCPS) utilized the services of U.S. OMNI & TSACG to assist with the
  preparation of bid specifications and the evaluation of the received proposals.
- All providers bid a mutual fund platform for equal pricing comparison. The mutual fund platform supports a reduced overall cost and fee to employees.
- Fees and rates quoted shall be guaranteed for the initial contract term.
- A committee of FCPS staff members and Insurance Council members independently reviewed and evaluated each proposal. Fee proposals were opened for firms scoring a total of 60 points or higher. Selection is paced on the total score of each bidder's technical and cost proposal.
- This recommendation has been reviewed and approved by the Insurance Council which consists of members from FCPS, Frederick County Teachers Association (FCTA), Frederick Association of School Support Employees (FASSE) and Frederick County Administrative and Supervisory Association (FCASA).
- The contract will be administered by Sarah Minnick, Senior Manager Benefits and Wellness, Human Resources.
