	Department for Frederick County Public Schools (FCPS). Bids were opened on July 25, 2023.

### 3. Other facts:

- The contract term will be effective from the date of award through August 31, 2025, with two additional two-year renewal options available.
- Approximately \$31,244 was expended in FY22 and approximately \$212,053 was expended in FY23 for vehicle repairs.
- Award of this contract is recommended to all vendors to fill the necessary repair capacity needs for FCPS.
- Colonial Equipment Company and Mark's Equipment Service, Inc. are to be awarded for light duty repair.
- Central MD International Trucks LLC, Colonial Equipment Company, J & M Truck Repair, Inc., Marks
  Equipment Service, Inc., and Testerman Bus Service are recommended for medium duty repair. Each
  vendor has a specialization needed to maintain efficiency within the department.
- This contract will be administered by Joseph lannuzzi, Fleet Maintenance Manager, Transportation.
- 4. **Source of funding**: FY24 Approved Operating Budget and contingent upon FY25 and FY26 Operating Budgets Board approval.
