FACT SHEET

A. **Overview:** This recommendation is to renew the contracts with qualified licensed nursing agencies (not individual nurses) to provide private duty nursing services for the care of medically fragile students during the school day.

1. **Other Facts:**

- The renewal term will be effective July 1, 2024 through June 30, 2026, with no renewal options remaining.
- During the initial contract term, approximately \$799,694 has been spent. (FY23 = \$373,632; FY24 = \$426,062)
- These services support a student while they are accessing their education to ensure their health and safety.
- Frederick County Public Schools makes no commitment to any agency for a minimum or maximum number of assignments, hours or overall value of work.
- Prices for the renewal term remain unchanged from the original bid prices.
- This contract will be administered by Jenifer Waters, Health Service Specialist, Student Services.

2. **Source of Funding:** Contingent upon Board approval of FY25 and FY26 Operating Budgets.

B. **Recommendation:** Staff recommends that RFP 22MISC13, Contract Service Agencies for Private Duty Nursing, be renewed to various vendors per the attached Summary of Renewal.
