GRADUATION
Policy 405

A. Policy Purpose

To ensure the promotion and graduation of students are in accordance with criteria issued by the Maryland State Board of Education (State Board) and the Board of Education of Frederick County (Board) policy as set forth below.

B. Definitions

1. “GED®” is defined to mean the nationally recognized high school equivalency test program.
2. “Maryland Comprehensive Assessment Program” or “MCAP” is defined to mean state-mandated assessments, that are aligned with and measure a student's skills and knowledge as set forth in the Maryland Standards for subjects identified in the Code of Maryland Regulations (COMAR).

C. Policy Statement

The mission of a high school in the Frederick County Public Schools (FCPS) system is to challenge and support all students regardless of race, ethnicity, language, gender and citizenship status to grow intellectually, personally, and socially so that each and every student is prepared for lifelong learning experiences, post high school education, and employment.

D. Implementation

1. **Graduation Requirements – 25 credits**
 - a. **State Requirements – Students Entering Ninth (9th) Grade 2020-2021 or Sooner.**
To be awarded a diploma, a student shall be enrolled in a Maryland public school system and shall have earned a minimum of twenty-one (21) credits that include the following specified credits:

* 1 must be Algebra & 1 must be Geometry; Mathematics is required for every year of attendance, up to 4 years.

** These 5 credits must include ½ credit for Personal Financial Literacy for students entering 9th grade for the first time during or after the 2012-2013 school year.

- b. **State Requirements – Students Entering Ninth (9th) Grade 2021-2022 or Later.** A student shall be enrolled in a public school system and shall have earned a minimum of twenty-two (22) credits that include the following specified credits:

Social Studies	3 Government, United States History & World History
Fine Arts	1
Computer Science, Engineering or Technology Education	1
Physical Education	½

¹ Graduation requirements that are in addition to high school graduation requirements established by the State Board for a student in foster care or who is a homeless youth shall be waived if that student transfers into FCPS from a different local school system in the state in grade 11 or grade 12. Such waiver may not occur if the principal makes a determination that the student is reasonably able to complete graduation requirements in time to graduate from high school.

A student who enters a local school system during their senior year shall be granted a waiver from locally established graduation requirements unless the student chooses to fulfill the requirements.

* 1 must be Algebra & 1 must be Geometry; Mathematics is required for every year of attendance, up to 4 years.

** These 2-½ credits must include ½ credit for Personal Financial Literacy through enrollment in applicable courses listed in the High School Course guide.

*** Up to 2 Electives credits may be satisfied by CTE program credits.

c. State Assessment Requirements

- i. Students meet the state assessment requirement as defined in COMAR 13A.03.02.06 by completing courses identified in [FCPS Regulation 416-01, Grading, Reporting, and Intervention – Secondary](#).
- ii. A student may meet the mandated assessment requirements in the following ways:
 1. By taking the state assessment designated for courses or the designated equivalent course assessment; or
 2. through a waiver of the Maryland High School Assessment (MHSA) graduation requirement in certain circumstances.
- d. **Total Requirements for Graduation from FCPS.** The total minimum number of credits required to graduate is twenty-five (25) credits.
- e. **Completion of the Following Additional Programs³**
 - i. Student Service Learning.
 - ii. Environmental Literacy.
- f. **Alternatives to Four-Year Enrollment.** Students shall satisfactorily complete four years of approved study beyond 8th grade unless one of the alternatives is satisfied in the COMAR State Board of Education Graduation Requirement Bylaw and [FCPS Regulation 400-34, Alternatives to Four-Year High School Enrollment](#).
- g. **High School Diploma by Examination (i.e., GED®)**
 - i. With the exception of paragraph D(1)(g)(ii) below, an individual may obtain a high school diploma by examination if the individual:
 1. Has not obtained a high school diploma;
 2. Resides in the State of Maryland;
 3. Is not subject to compulsory school attendance under Maryland law; and
 4. Has withdrawn from a regular full-time public or private school program.

³ The curricular objectives identified in paragraphs D(1)(e)(i) and (ii) are embedded within the Frederick County Public Schools curriculum and may not represent specific courses.

- ii. An individual is not subject to the requirements of paragraph D(1)(g)(i) above if the individual participates in a GED® Option Program administered by the Maryland State Department of Education by examination for currently enrolled high school English learner students under the age of 21 years who have experienced interrupted education and have a lower level of English proficiency than their peers.
2. **Early Completion of State Requirements Graduation**
 - a. Early graduation means the completion of all requirements for a Maryland high school diploma in less than the regular four-year senior high school program.
 - b. Increasingly diverse learning opportunities for high school students now make it possible for some students to complete graduation requirements in less than four years.
 - i. Both educational and personal considerations suggest that most students should remain in the public schools through twelfth grade. However, alternative plans may be approved including a waiver of the fourth year enrollment requirement if all credits, assessments, and student service requirements are met and the superintendent or designee determines the waiver is in the best interest of the student. A variety of factors will be considered when making determinations to allow a student to waive the fourth year including, but not limited to career skills, academic performance, and post-graduation plans.
 3. **Commencement Exercises.** The Board acknowledges that commencement represents a ceremony of celebration and student participation is deemed a privilege and not a right. It is the expectation that schools conduct commencement ceremonies in accordance with budget allocations as determined by the Department of System Accountability and School Administration.
 4. **Graduation Honors and Awards.** High schools recognize exemplary academic achievement using the designations of Honors, High Honors, and Highest Honors. Additionally, students who have met the necessary *Maryland Business Roundtable for Education* requirements will receive a Maryland Scholar designation.
 5. **Annual Review.** The Board will annually review this policy and staff will provide notification to the community of graduation requirements.
